Thank you for your timely and thoughtful response.

Another procedural difficulty that I anticipate is the 3 minute rule for speakers. I understanding, generally, the need to reasonably limit public comment. The difficulty for those of us that understanding the complexity of urban systems, and attempting to find a way to communicate a path through such systems, is that it takes time to make a point. Three minute limits make that ever more difficult The alternative, submitting explanations in writing, takes us back to the point I raised in the last email. I suspect that the information we intend to present to staff on Monday will illustrate this point.

Usually, we would handle these deficiencies through private meetings with Subcommittee members, but staff has the members believing that such meetings would be inappropriate and members have refused them. It's a kind of triple bind.

By the way, I would encourage a discussion about the role of the Subcommittee in the very near term. I think that staff has a unique and constrained view of its role.

One alternative is set up a secondary process, not under the aegis of the city, to inform the public and any attending Subcommittee members to presentations of the data otherwise denied them by the process. I think that you would agree that this is a decidedly inferior way to conduct the process.

I look forward to a "process" discussion in the near term.
