Attached is the write up without the slide noted in my 518pm email below. I did include this slide when I submitted my suggestion for a potential study site on July 12 and could be the reason my July 12 suggestion was not captured by the system.

I nominate the Hillsdale Station as a potential study area due to its current Cal Train ridership, it's future ridership forecasts and its proximity to;

- Two very large housing developments , Bay Meadows and the 705 unit Hillsdale Garden apartments,
- Newly renovated Hillsdale Shopping Center ,
- Future Bohannon hi-density apartments. To be located at the current ANA's furniture and closed TGIF restaurant,
- Hi-density of single-family homes and,
- Its preeminence in the ongoing overhaul of the city's Master Bicycle Plan. The plan's objective is to ensure safe routes to transit centers like Hillsdale Station for bicycles, e-scooters and other personal mobility devices. The update will be completed in early 2020.

I believe the Hillsdale Station is a solid study area for the five reasons outlined above.
