overall i am very saddened by this process. It has not been as inclusive as it should be and in order to participate one must by able to use and have access to computer technology.

These maps are NOT intuitive, the areas and shading are overwhelming to view and interpret.

My feedback in summary is, we need an excellent , coordinated public transit system. One ticket for train, BART, bus, etc not several systems with different tickets

and payment systems. We need to upgrade and plan for freeway improvement and size increase- 92 is no longer going to be able to hold the increases in cars you are proposing to add to our city. It is already a parking lot after 3pm with our current traffic patterns, even with Covid changes. Development needs to be centered near public transit access.

Single family housing in our neighborhoods needs to be left as is. People bought homes in existing neighborhoods for a reason.

The idea that a consulting group who does not live here can make reasonable recommendations without experience living, driving and shopping in our city is not realistic. During one of the 'zoom sessions' a question was asked about the one way streets in downtown, the consultant was not aware of the current one way streets....

Park space needs to be increased, not 'private open space' but outside space for residents to enjoy. Look at the use our parks get currently. Add 11,000-20,000 new residents, we need more open space.

More effort needs to be made to engage neighbors.... maybe surveys in the mail., or at the library, or schools. This online 'survey' is not adequate.
