
## Draft General Plan 2040 Key Themes

Circulation	<ul> <li>Increases active transportation modes to reduce greenhouse gas emissions.</li> <li>Requires new development to reduce motor vehicle trips.</li> </ul>	<ul> <li>Reduces single-occupant vehicle trips to reduce air pollution that affects equity priority communities.</li> <li>Prioritizes new transportation amenities in equity priority communities.</li> <li>Recommends safety improvements near transit stops for residents who cannot drive or do not have access to a car.</li> </ul>	<ul> <li>Involves the community early in the process so that improvements reflect community input.</li> <li>Engages seniors, students, transit users, community organizations, and residents of equity priority communities to provide input on solutions for different users.</li> </ul>
Community Design and Historic Resources	<ul> <li>Encourages sustainable design features into building design.</li> <li>Supports new development that respects and responds to the natural topography.</li> <li>Supports the preservation of historic resources which reduces the consumption of new construction materials.</li> </ul>	<ul> <li>Adds climate-adapted trees in neighborhoods with less street tree canopy.</li> <li>Explores funding sources and other support for low-income homeowners to plant and/or replace trees on their properties.</li> </ul>	<ul> <li>Collaborates with Native American representatives to identify locations of importance to Native Americans</li> <li>Increases public appreciation of historic resources.</li> </ul>
Conservation, Open Space, and Recreation	<ul> <li>Protects the City's natural resources.</li> <li>Affirms all San Mateo residents should be able to breathe safe, clean air.</li> </ul>	<ul> <li>Prioritizes enhancement of natural landscapes in or near equity priority communities.</li> <li>Requires mitigation for activities that could be a source of toxic air contaminants (TACs).</li> <li>Prioritizes rehabilitation of parks and recreation facilities in equity priority communities.</li> </ul>	<ul> <li>Fosters appreciation for conservation opportunities through City programs and outreach.</li> <li>Provides opportunities for personal enrichment and lifelong learning.</li> </ul>
Public Services and Facilities	<ul> <li>Manages wastewater and stormwater to protect water quality in our waterways.</li> <li>Maintains the quality of public services as the city grows.</li> <li>Supports solid waste reduction and recycling.</li> <li>Supports plans for water management and conservation.</li> </ul>	<ul> <li>Provides for the equitable distribution of public services and facilities.</li> <li>Supports efforts to provide better healthcare services in equity priority communities.</li> <li>Commits to code enforcement that advances equity.</li> </ul>	<ul> <li>Supports community access to public facilities that foster connections and learning opportunities.</li> <li>Informs the community about public services and facilities improvements.</li> </ul>
Safety	<ul> <li>Encourages the use of natural systems to protect the community against sea level rise.</li> <li>Ensures the cleanup of hazardous materials contaminated sites.</li> </ul>	<ul> <li>Focuses emergency readiness in equity priority communities and the most vulnerable areas.</li> <li>Prioritizes locating critical facilities and resilient infrastructure outside of hazard-prone areas.</li> </ul>	<ul> <li>Informs the community about safe and effective evacuation methods.</li> <li>Ensures inclusive outreach about potential hazards.</li> <li>Supports Community Emergency Response Team (CERT) training.</li> </ul>
Noise	<ul> <li>Reduces noise levels to improve the health and well- being of our community and habitats.</li> </ul>	Minimizes and mitigates noise impacts.	<ul> <li>Informs the community about upcoming land use projects that would contribute to or be affected by a noisy environment.</li> </ul>
